## Membership Information

Thank you for your interest in Arlington Neighborhood Village (ANV). Our goal is to enable members to continue living in their own homes and communities as they age—safely, independently, and with an enhanced quality of life. If you are 55 or older and live in Arlington County, you are eligible to apply for ANV membership.

Becoming a member is a two-step process. The first step is to complete and return this Contact Information Form to the ANV office. After a further conversation about ANV to share information about your interests and needs, there is a Member Application Form that needs to be completed and that will lead to an in-home (or Zoom) interview with an ANV volunteer to gather additional information and answer any questions you have. If you and the ANV representative agree that village membership will meet your needs, you will be asked to sign a Membership Application and Agreement and pay the appropriate membership fee.

### **ANV has two membership categories:**

**Full Membership** entitles you to take part in all program and social activities, and to receive direct volunteer services. The annual fee for one person is \$500. The yearly fee for each additional member in a household is \$250. Discounted membership\* is available for those who need financial assistance with the membership fee. Discounted memberships are tied to income and are available to applicants earning less than \$47,250 annually (for an individual)

**Associate Membership** entitles you to participate in all programs and social activities. It does not include transportation or other volunteer-provided services. Associate membership is appropriate for those who do not currently have a need for volunteer-provided services. The annual fee is \$500 for either an individual or household membership. Since services are not provided, \$375 of the annual fee is considered a charitable contribution for the general support of ANV and may be tax deductible.

\*A discounted membership is available for full members whose annual income is below the threshold (currently \$47,250 for an individual and \$50,400 for a household). An individual qualifying for discounted membership will pay an annual ANV membership fee ranging from \$100 to \$25 based on income. If you are requesting a discounted membership, at the time of your member interview, you must provide proof of income which can include for example, the first page of your most recent federal income tax return.
